Final Approval: Prior to beginning construction, owner/builder must receive final approval to build from the ACC/HOA. *See #6 on the Procedures document for instructions.* The ACC requires applicants to pay the following:

- ACC Road Usage Fee (nonrefundable) \$1,000
- ACC Compliance Deposit (refundable) \$4,000

Deposit is held in escrow until the successful completion of the project. If no penalties have been imposed by the ACC during the course of the project, the full deposit amount will be refunded.

Request to build must comply with the Architectural Design Standards to receive ACC/HOA Board approval prior to proceeding to Port Royal to obtain builder permit.

All builders must be licensed in SC with a portfolio of residential builds of similar quality and style as existing homes in Pinckney Retreat. If the builder has not previously built in Pinckney Retreat, the ACC will review potential candidates for approved builder status.
